

Sub: Coming for inspection of documents as per GR 26.11.2018 under video recording on 28.11.23 in the matter
of illegal obstruction on road, footpath and traffic islands under guise of beautification.

Req: on 28.11.23 no inspection was granted as no such legal process was followed and there is
illegal obstruction on road, footpath and traffic island

I had visited B ward on 28.11.23 around 3.30 pm. Asst Commissioner was not available. Marathe. No documents sought were provided as no such legal process was followed.

Hence, the submission made by DMC zone-1 that permissions have been obtained after following law is false, incorrect misleading and an attempt to shield and protect illegal construction and obstruction on road, footpath and traffic island. Hence all the illegal construction and obstructions are required to be demolished

- a. Study carried out on impact of motorist and pedestrian movement which endangers life and limbs and as well loss injury to public property
- b. Consultation with public after giving wide publicity
- c. Traffic police
- d. BMC road chief engineer
- e. Underground utility agencies

- g. Local police station.
- h. Regulatory authorities
- i. Change in shape and size of dividers to convert into central median
- j. Change the dimensions of dividers
- k. Install objects more than 60 mm or 2 ft.

2. Types of illegal construction and obstruction protected by Addl MC, DMC and Asst Comm

1. flower beds on road and footpath

2. reading rooms with name of politicians on road and footpath

3. chowks with concrete structure in the middle of road or footpath

4. illegal names of junctions with huge concrete slabs (legally permissible 7 ft pole with 2 ft board of metal with blue color)

5. tree protection walls up to 2.5 to 3 feet (legally 3 inches)

6. illegal structures on traffic islands of concrete

7. illegal huge gates on roads

8. conversion of divider into illegal traffic islands to illegally construct structures (reducing usable space of road and footpath)

9. conversion of dividers into median garden (reducing usable space of road and footpath)

10. erection of bamboos on road and footpath for banners and posters (disturbing / obstructing the vision of motorists and pedestrians)

of private encroachers / furniturewalas / butchers / extended shopkeepers etc (B , C, E wards have which can be used by pedestrians)

al food trucks or any type of trucks carrying business on road (obstructing free movement forists and pedestrians

heavy lighting and digital screens which blind the motorists

15. bombards and flower pots (Senapati Bapat marg and near Race Course)

16. garden strips on footpath

17. huge boards of politicians below any bridge (like I love Mumbai)

18. Banners and boards of politicians illegally advertising the funds used. These funds are tax payer money. Hence, no politicians / elected representatives have any legal right / authority to claim and advertise the work done as SEVA for which they are showered with heavy benefits and luxurious perks.

Lets us work for better Mumbai.
